

# How Bout Them Apples Blog Sweepstakes Official Rules

**No Purchase or Obligation is Necessary to Enter or Win. Non-Comment Entries and Comment Entries have an Equal Chance of Winning.**

**1. To Enter:** The Sweepstakes begins February 1, 2010, and ends February 28, 2010 (“Sweepstakes Period”). Entry into Sweepstakes is achieved via posted comments on the Blog HowBoutThemApples.org. Limit one entry per person, per Blog post, per day on HowBoutThemApples.org. Maximum number of entries per month is 10. Valid name and email must be provided. Email address will not be displayed for the public to view alongside the post on the Blog site. Comment must be appropriate. Any vulgar, crude or otherwise deemed inappropriate comments will be omitted from entry. Apple Federal Credit Union reserves the right to edit blog posts.

**To enter without purchase or obligation,** hand-print your name, address, city, state, zip, day and evening phone numbers, and the words “How Bout Them Apples February” on a 3” x 5” card, and mail in a stamped #10 envelope to: Apple FCU, Attn: How Bout Them Apples, P.O. Box 1200, Fairfax, VA 22038. Mail-in entries must be postmarked by February 28, 2010 for inclusion in the February random drawing.

**2. Eligibility:** Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are twelve (12) years of age or older as of February 1, 2010. Apple employees, Board members and their immediate family members (spouse, parents, children, siblings and their spouses or individuals living in the same household) are NOT eligible to participate. Sweepstakes void where prohibited or restricted by law. Federal, state and local taxes are the sole responsibility of the prize winners. Sweepstakes is subject to all applicable federal, state (Virginia) and local laws and regulations. No substitutions or transfers of prize permitted except at sole discretion of sponsor. By participating, entrants agree to these official rules and accept decisions by Apple Federal Credit Union as final.

**3. Odds:** The odds of winning will be determined by the number of participant transactions during each month.

**4. Prize Drawing:** One (1) prize winner will be selected for the month of February to win the gift card. The random drawing will take place on or about March 15, 2010 from all eligible entries as noted in section 1 between February 1 and February 28, 2010.

**5. Winner Notification:** Winner will be notified via email on or about March 15, 2010. Prize must be picked up at the Apple Federal Credit Union Headquarters at 4029 Ridge Top Rd. Fairfax, VA. Winner has 30 days to claim their prize or eligibility is voided. Winner must present valid ID to claim prize. Valid ID includes a state-issued driver’s license, passport or school ID.
